

## HUNTING/FISHING LICENSES:

Seasonal Hunting, Fishing, Bow, Muzzleloader, Turkey and Lifetime Licenses are available during our regular business hours.

It is most helpful if you have your previous License or valid Driver's License available as it allows us to locate you in the New York State system with minimal difficulty.

For the latest information available regarding license requirements, changes, important dates, etc., please visit the New York State Department of Environmental Conservation at [www.dec.ny.gov](http://www.dec.ny.gov).

Lifetime License holders receive their privilege tags directly from New York State. Deer Management Permits (DMP's) **ARE** included with Lifetime License's purchased before 10/1/2009, Bow and Muzzleloading permits **ARE NOT** included in the Lifetime License, the applicable current fees will be collected.

To purchase a Lifetime License for a child, the purchaser must bring proof of the child's age (e.g. Birth Certificate or Passport) and proof that the child's residency is New York State. The parent or legal guardian's New York State Driver's License is an example of that proof. **PLEASE REFER TO THE LIFETIME LICENSE INFORMATION SHEET for complete information regarding Lifetime Licenses.**

## LIFETIME LICENSE INFORMATION SHEET

### Congratulations!

You are now the proud owner of a lifetime license. The following explains how our lifetime license process works.

- **Adults** – Once you have purchased your lifetime license, all future licenses and tags (where applicable) will be sent to you annually from our fulfillment center by September 1<sup>st</sup> provided you have the appropriate sportsman education in your file. You may apply for a first round Deer Management Permit online ([www.dec.ny.gov/permits/365.html](http://www.dec.ny.gov/permits/365.html)), by phone (1-866-933-2257) or at any agent location. You do not need to wait for your lifetime license to come in the mail to apply for your Deer Management Permits.
- **Children** – After the initial purchase of a lifetime license for a child, there will be no fulfillment of any license or tags (where applicable) until he/she reaches the appropriate age of eligibility. If the lifetime license includes hunting, individuals 12 years and older will need to take the appropriate Sportsman Education course. You may take these course(s) starting at age 11. Fishing license privileges will not be fulfilled until age 16 since children under the age of 16 do not need a license to fish.
- After completing your course(s), you will need to have your Sportsman Education certificate(s) added to your license profile. License holders are able to locate their online account at <https://decals.dec.ny.gov/DECALSCitizenWeb/citizenhome.htm> and add their sportsman education. After locating your account you will need to log in, check that you read the disclaimer, answer "yes" to edit your profile and add your Sportsman Education. After adding your education online, be sure to click the "Save Changes" button. You can also send a **copy** (front and back) of your Sportsman Education certificate(s) to the License Sales Unit at 625 Broadway, Albany NY 12233-4790, fax to (518) 402-9025, email [fw.information@dec.ny.gov](mailto:fw.information@dec.ny.gov), or call the Call Center at 1-866-933-2257 (Monday-Friday 8:30 am-4:30 pm). If faxing, emailing or mailing copies of your certificates, please be sure to rewrite the certificate number(s) and course dates. Many times they are not clear enough for us to read. Also be sure to include a phone number you can be reached at during the day in case we have questions. Do not wait until the day before you need your license and tags to take care of this. It will take up to 14 business days to receive your tags. If you wish to receive your license and carcass tags before 14 business days, you will be charged the \$15 replacement fee.
- All lifetime licenses are valid for the holder's lifetime no matter where you live, even outside New York State. However, it is **your responsibility** to notify us of any address changes. Failure to do so can result in your not receiving your license/tags. Always be sure to include your date of birth and new telephone number with all address changes.
