# TOWN/RESOLUTION NO. 33, 2023/AWARD ELECTRICAL CONTRACT TO DJ GERLING ENTERPRISES, INC. FOR UTILITY WORK AT ADA COMPLIANT RESTROOM ONTARIO STREET PARKING LOT

A MOTION was made by Councilwoman Rutland, second by Councilman Barnes to adopt the following Resolution No. 33, 2023 which was introduced by Supervisor Syracuse as follows: Award Electrical Contract to DJ Gerling Enterprises, Inc. for Utility Work at ADA Compliant Restroom Ontario Street Parking Lot, Whereas, the Town Board of the Town of Newfane selected an ADA compliant restroom per Resolution 23, 2022, and Whereas, the fabricated restroom facility, pursuant to said Resolution, was provided by Sevenson Environmental Services, Inc. and included improperly located electrical box, not meeting current code, Whereas, the restroom required electrical power delivery to this structure, and also required modification to the existing electrical box within the restroom utility closet, in order to comply with code requirements, and Whereas, DJ Gerling Electrical was hired to perform said electrical work, at a cost of \$9,775.00, the sum of \$4,925.00 of said amount being attributable to the cost of complying with the code requirements, Now Therefore Be It Resolved, The Town Board of the Town of Newfane approves payment to DJ Gerling Electrical in the amount of \$9,775.00, and Be It Further Resolved, the amount of \$4,925.00 be deducted from Sevenson Environmental Services, Inc. remaining retention to offset the cost of DJ Gerling Enterprises, Inc. to relocate electrical box from inside room to exterior wall to comply with current codes.

# TOWN/ADOPT RESOLUTION NO. 34, 2023/ADOPTING A FAIR HOUSING PLAN AND DESIGNATING, SECTION 3 AND LABOR STANDAD OFFICERS FOR THE TOWN OF NEWFANE

A MOTION was made by Councilwoman Neidlinger, second by Councilwoman Rutland to adopt the following Resolution No. 34, 2023, Adopting a Fair Housing Plan and Designating, Section 3 and Labor Standards Officers for the Town of Newfane as follows which was introduced by Supervisor Syracuse: Whereas, the Town of Newfane is a recipient of Community Development Block Grant (CDBG) funding through the United States Department of Homes and Community Renewal, administered by the New York State Governor's Office for Small Cities; and Whereas, the rules and regulations governing the Community Development Block Program require that the Town be responsible for taking specific actions to affirmatively further fair housing (AFFH) practices in the Town; and Whereas, the rules and regulations governing the Community Development Block Program require that the Town be responsible for ensuring compliance with Section 3 of the Housing and Urban Development Act of 1968, as amended including the appointment of a Section 3 Officer to oversee compliance; and Whereas, the rules and regulations governing the Community Development Block Program require that the Town be Responsible for ensuring compliance with Davis Bacon and Related Labor Standards Acts including the appointment of a Labor Standards Officer to review and/or oversee compliance; Now, Therefore, Be It Resolved, that it is the policy of the Town to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, religion, sex, handicap, or disability, or familial status or national origin, and that discrimination in the sale, rental, leasing, financing of housing to be used for construction of housing, or in the provision of brokerage services, because of race, color, religion, ancestry, sex, national origin, handicap or disability, is prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Housing Law); and Be It Further Resolved, that the Town will undertake the following AFFH actions within one (1) year of the award of CDBG funds; 1. Display fair housing posters and distribute fair housing materials prepared by New York state, the municipality, U.S. Department of Housing and Urban Development (HUD), or fair housing organizations to community residents, landlords, real estate professionals and lenders.

A MOTION was made by Councilman Barnes, seconded by Councilwoman Rutland to adopt the following Resolution No. 36, 2023, Wastewater Treatment Plant Sludge Pump Station Emergency Declaration in which Town Engineer, Brian Sibiga explained the work that needs to be done. Whereas, the Town of Newfane (the "Town") owns and maintains the Newfane Wastewater Plant, 6349 E Lake Road, Burt, New York, wherein the plant has a sludge pumping station that contains various pumps, valves and piping to convey waste activated and return active sludge to various areas of the plant, and Whereas, the Town of Newfane wastewater treatment staff has reported leaking pipes and deterioration of the existing facilities in the pump station, and Wendel, the Town Engineer of the Town of Newfane examined the facilities in the Sludge Pump Station, and Whereas, Town engineers, Wendel, have analyzed the system failure and have prepared the attached report referenced as 'MEMO RE: Wastewater Treatment Plant-Emergency Repair" (the "Wendel report") which is referenced and incorporated hereto, and Whereas, the Wendel report describes the importance of the Sludge Pump Station System(S) to the life, health, safety and/or property of the residents of the County of Niagara, and Whereas, Wendel opines that "It is Wendel's opinion that these circumstances, if allowed to continue without emergency repair, could jeopardize the life, health, safety and/or property of the customers of the Town of Newfane." Now Therefore Be It Resolved, that the Sludge Pump Station Failure at the Town's Wastewater Treatment Plant is a public emergency arising out of unforeseen occurrences or conditions whereby circumstances affecting the

A MOTION was made by Councilwoman Neidlinger, second by Councilman Barnes to adopt the following Resolution No. 37, 2023 as follows: Whereas, the Town of Newfane (the "Town") owns and maintains the Newfane Wastewater Treatment Plant, 6349 E Lake Road, Burt, New York, wherein the plant has an aeration system that includes air supply blowers, vales, appurtenances and actuators and Whereas, the Town of Newfane has one existing positive displacement by Gardner Denver with associated valves, actuators and appurtenances and Whereas, the Town engineer, Wendel, have submitted a recommendation letter, attached and incorporated to this resolution, dated July 25, 2023, which recommends standardization on Gardner Denver for the air supply blower, valves, actuators and appurtenances as part of one supply package at the Newfane Wastewater Treatment Plant aeration system, and sets for the reasons why the Town will benefit economically as well as gained efficiencies if such standardization is declared, now therefore be it Resolved, that the Town hereby accepts and incorporates the findings and recommendations set forth in Wendel's July 25, 2023 letter, attached hereto, and be it further Resolved, that the Town, for reasons of efficiency and economy as authorized by Section 103 (5) of the General Municipal Law, and for the reasons set forth in the attached recommendation letter, does hereby standardize on the use of Gardner Denver for all air supply blowers and associated equipment for the aeration system at Newfane Wastewater Treatment Plant, at this time or any time in the future, until such time as this resolution is rescinded. Further Resolved, the Koester Associates is the sole source supplier of Gardner Denver blowers in New York and the Town Supervisor is authorized to sign documents required to purchase the blower package from Koester Associates in an amount not to exceed \$92,375.
