## REPORTS OF COMMITTEES AND DEPARTMENT HEADS

Mike Mills, Water Superintendent, indicated all is going well, the needed rain has helped. He informed the Board that he is allowing people to send in pictures of their water services, along with the water meter, to help eliminate him and his crew going door to door to so many homes, very time consuming and they are very busy. He has ordered the parts for West Lake Road at the corner of West Creek Road and hopes to get started on that in the next couple of weeks. Nick Irr, Wastewater Treatment Plant Operator, indicated the project at the Plant is coming along nicely, plenty of compost available and the septic haulers are having no problems getting in and out. David Schmidt, Building Inspector/Code Enforcement Officer indicated he is plugging along, he is down to two Short Term Rentals that he has left to do. He will then begin looking for those that never applied and are running without a permit. Edmunds is installing a computer program that will allow him to keep track of all the businesses that will also need an annual inspection, along with a program that

will allow him to keep track of vacant properties that he will then be able to keep an eye on. Councilman Robinson gave an update on Tourism on behalf of Gina Redden who was not able to attend. He went through the special events such as Carousel Park outdoor movies, Christmas in July, Bicentennial Pioneer Picnic, the National Band Organ Rally, the award of the 2024 Arts Council Grant, the increase of demand for the Visitor's Guides, the increase of documented views on the online event calendar as well as the events funded by the Tourism Board.

David indicated that he has sent letters of notification to all the businesses he was aware of as well as to individuals on a list provided by the Fire Companies for properties that they recommended. David indicated to Mr. Wagner that his records show he only has 4 units and is not required to have a Knox Box. Mr. Wagner indicated that he has 6 units. Mr. Wagner expressed his displeasure of First Responders having access to a key to get into his property.

Max Russell, Hess Road, Appleton, just wanted to respectfully request the Board keep drainage at the forefront of their minds if possible. Both irrigation and drainage are of utmost importance to the farming community.
