## TOWN/WWTP/REQUEST HIRE SUMMER HELP/NICHOLAS

The Town Clerk read correspondence from Nicholas Irr, Chief Operator of the Wastewater Treatment Plant, requesting to hire Christopher Nicholas to work as Summer Help at the Wastewater Treatment Plant. Job duties will consist of building and grounds maintenance at the WWTP, Pumping Stations and Compost Plant. Pay to start at \$17.00 per hour, beginning on May 6, 2024, and ending in September.

The Town Clerk read correspondence from Jon Miller, Highway Superintendent, respectfully requesting permission to attend 2024 Highway Superintendent School in Ithaca, NY, on June 2 – June 5, 2024, with the cost not exceeding \$800.00 for registration, hotel and food. Supervisor Syracuse asked for a MOTION to approve Highway Superintendent Jon Miller's request. Moved by Councilman Coleman, second by Councilman Horanburg on the question. # TOWN/SUPERVISOR/RECAP OF AMBULANCE USE/MILLER HOSE/OLCOTT FIRE CO.

The Supervisor offered a recap for the Newfane Residents on the status of the proposal for Miller Hose Fire Company and Olcott Fire Company to begin billing for ambulance services. This is something allowed by law and is perceived to be a win/win for the Fire Companies as well as the public. The Supervisor invited personnel from the Fire Companies to come and speak about the process they are hoping will be implemented. Michael Miller, Olcott Fire Company, explained that Governor Hochul passed a law in 2022 allowing Fire Companies to bill for ambulance services. While other Fire Companies implemented the billing service they wanted to wait and see how it would all play out. With the rising costs of material, gas, mileage, etc., they are looking at a soft billing option. Essentially, if you are a Town of Newfane Resident the Insurance Company will be billed. They will not charge a co-pay and if the resident does not have insurance, they will pay nothing. In the past, the hospitals would help by restocking the medical supplies for the ambulance for the patient that was brought in, that is no longer happening. Shannon Coleman, Olcott Fire Company, also reiterated that supplies were depleting prior to covid, however, when covid hit the were getting no help from the hospitals. The cost of medical supplies greatly increased and became difficult to get. The Supervisor indicated that if we do not have the aid of our volunteers, causing a private ambulance company to respond, there will be no forgiveness on the billing. It is becoming clear that this would be the way to keep our volunteers and assist our residents. All funds received for ambulance services by the local Fire Companies goes right back into the EMS Service.

# REPORTS OF COMMITTEES AND DEPARTMENT HEADS

The following department heads were in attendance and gave a report on their department. Water Superintendent, Mike Mills, indicates that there is a lot going on with the water line sizing and what they are made of. We have about 4,000 services in Town, and with the work of Wendel Engineering, we have it narrowed down to about 2,000. The water department is going door to door, leaving letters at residences, that they need to schedule appointments for the guys to get into the homes to check for lead. Mike Mills indicated in his 23 years here he has only seen 1. He understands why the State is doing this, but it is a lot of additional work on the staff and needs to be

done by October of 2024. In addition to that we have more water taps and are trying to finish the East Side of Route 18 and working on Lake Road plans.

The Chief Operator of the WWTP, Nick Irr, advised that there is compost available to the Town Residents at no charge. The workers are back at the plant and are continuing work on the upgrades. He is working on straightening out an issue with disinfecting as our chlorine limits have been lowered.

Gina Guido-Redden, Tourism Committee, advised they are getting ready for the eclipse. Almost all of the businesses that are closed on Mondays will be open, the shops at Village Fair will be open, Gina thanked Mike Mills for getting the bathrooms in Olcott open for them. The companies that do rental tracking show our projections for 2024 have increased greatly and we have new businesses popping up in Olcott and Newfane which we are really excited about.

David Schmidt, Building Inspector/Code Enforcement Officer, advised now that the weather is getting warmer it's getting busier. The Short Term Rentals are coming along, the tiny homes are starting to come in and he is down to one more certification and he will no longer need assistance in signing off on any paperwork.

## TOWN/RESOLUTION NO. 6 – 2024/CONTRACT WITH SONITROL

WHEREAS, the Town of Newfane is desirous to upgrade its current 3G monitoring system which is out of date, and also desires transition to 5G system, and WHEREAS, this new 5G monitoring system will provide upgrades to most cameras and their location along with further upgrades from the antiquated "dial-up" mode, to a more efficient "internet-enhanced" program, and WHEREAS, the Town of Newfane will also provide new surveillance monitoring systems at our Wastewater Treatment Facility located at 6349 E Lake Road, Olcott, NY 14126, and WHEREAS, this resolution replaces and rescinds Resolution No. 49-2023 and Resolution No. 58-2023, and now therefore be it RESOLVED, that the Town Board of the Town of Newfane approves four (4) contracts attached hereto and does hereby direct the Town Supervisor to enter into said contract, and be it further RESOLVED, the funds used to pay for these goods and services will come from the dollars ascribed from ARPA

## TOWN/RESOLUTION NO. 7 – 2024/OLCOTT/JAZZ FESTIVAL

WHEREAS, Olcott Beach is a major tourist area in the Town Of Newfane, due to its location on Lake Ontario, and the many attractions it offers tourists, such as being a premier fishing location in New York State, being the location of the Olcott Beach Carousel Park, having the most beautiful park in Niagara County, a freshly sanded beach with lifeguards for swimming, numerous bed and cottages and motels for tourists and fishermen, fine restaurants, the location of breakfasts, many the Lakeside Village Shoppes, a unique and vibrant shopping center; and WHEREAS, Olcott Beach has many events in the summertime to attract tourists and citizens of the community, in order to bolster the businesses of Olcott Beach and the Town of Newfane in general, and thereby improve the economy of the area; and WHEREAS, the "Olcott Beach Jazz Trail" is a jazz festival to be held on September 1, 2024 in various locations in Olcott Beach, which will bring thousands of people to Olcott Beach, which will help the businesses and enhance the economy of same; and WHEREAS, it is in the best interests of the Town of Newfane to sponsor this jazz festival; NOW, THEREFORE, BE IT RESOLVED, that the Town of Newfane does hereby sponsor the jazz festival called the "Olcott Beach Jazz Trail", to be held on September 1, 2024, at various locations at Olcott Beach; and BE IT FURTHER RESOLVED, that the Town of Newfane selects James J. Sansone, as an independent contractor to organize said jazz festival, to serve without compensation or fee, and does hereby authorize James J. Sansone to select a committee to assist him in this endeavor, and further authorizes him to take any and all actions necessary, on behalf of the Town, including the closing and blocking of streets and /or sidewalks, the placing of bands, food trucks, signs or any other items necessary for the proper operation of the festival onto the sidewalk, street, and road rights of way of

the Town the obtaining and hiring of performers, and the obtaining of funding for said festival, towards the successful accomplishment of same.
